The CSRC has reviewed, in accordance with the laws, the application materials for administrative permission of the “Approval for Asset Acquisition through Share Issuance by Listed Companies” (《上市公司發行股份購買資產核准》) submitted by the Company. The CSRC considered that the application materials were complete and accepted the application for administrative permission.

The Company's Asset Acquisition by way of Share Issuance and Cash Payment and Raising of Supporting Funds is subject to the approval by the CSRC. Whether it will be approved by the CSRC and the time when such approval can be obtained remain uncertain. The Company will perform its obligations of information disclosure in a timely manner based on the review progress of the CSRC. Investors are advised to be aware of the investment risks.
